MINUTES

Of the meeting which took place on Wednesday 16th July 2014 immediately following the annual meeting at Calder Vale Village Hall.

1. **Present:**

2. **Declaration of interests**

Councillors J & T Ibison declared interest in agenda item 8. Tree preservation order 010/2014/TPO.

3. **Minutes**

It was resolved that the minutes of the meeting on 21ST May 2014 having been circulated previously be approved and signed by the Chairman as a correct record.

4. The meeting was adjourned for a period of public discussion, giving members the opportunity to update on any meetings attended, etc. Clerk was asked to report the hedge on Dimples Lane boundary to Leonard Cheshire as it is dangerously protruding into the road. Also Helmsdeep was mentioned on Long Lane and the odour which the environment agency had looked into was still there, particularly noticeable in dry / hot weather. Clerk will contact Rupert Denye again and request this is kept an eye on.

5. **Community Transport Scheme**

This was discussed. **It was resolved that the the clerk should respond to explain there is definitely a need for community transport, particularly in isolated areas such as Calder Vale village and Barnacre where bus service recently ceased. Mention that there is a weekly taxi service to Garstang from Calder Vale village which has been set up by local residents.**
